## I. Purpose

The purpose of this policy is to establish criteria relating to clubs in the schools.

## II. Definitions

- A. <u>Club</u> means a group of three or more students of a school who meet to pursue recreational, philosophical, or other activities which are not extracurricular in nature, including dance teams, chess clubs, language clubs.
- B. <u>Staff sponsor</u> means a teacher or other HCPS employee who oversees and supervises a club and who does not receive compensation for such sponsorship or oversight.

## III. Policy Statement

- A. Clubs are permitted provided:
  - 1. they are approved by the principal; and
  - 2. have a staff sponsor approved by the principal.
- B. All staff sponsors shall comply with all HCPS policies and procedures and shall adhere to HCPS scheduling, including inclement weather scheduling, in conducting club activities.
- C. HCPS sponsors may not plan, sanction or supervise a club activity which occurs at a private residence or property.
- D. No club or organization activity may occur at the private residences or property of sponsors.
