DECISION ON Transfer between State Categories for the FY2024 Budget

November 13, 2023

Background Information:

The Budget Office continuously monitors the status of revenues and expenditures throughout the budget cycle. At the fiscal year-end, actual expenditures cannot exceed amounts budgeted in each of the fourteen state reporting categories (Administrative Services, Mid-Level, Instructional Salaries, etc.) that comprise the HCPS Operating Budget. Inter-category budget transfers are necessary to align system resources with student needs, enrollment changes and staffing, program, facility, and service requirements.

Discussion:

Per the Blueprint section 5-213, beginning in fiscal year 2024 local school systems were to allocate \$62 per K-12 student to work with Local Workforce Development Board to implement career counseling for all 6-12 grade students. HCPS budgeted those funds in 103 Instructional Salaries because we thought HCPS was going to hire staff to provide those career counseling services. As the MOU was being developed between Susquehanna Workforce Network (SWN), Harford Community College and HCPS, and after receiving clarification from Maryland State Department of Education and the Accountability and Implementation Board, it became clear most of the funds were to be transferred to SWN. To facilitate that process an inter-category transfer is necessary between 103-Instructional Salaries and 105-Other Instructional Costs. The calculation for the transfer is:
