**DECISION ON AWARD OF CONTRACT
HICKORY ELEMENTARY SCHOOL
COMPREHENSIVE ROOF REPLACEMENT**

May 4, 2020

Background Information:

Bid documents for the Hickory Elementary School Comprehensive Roof Replacement Project were issued and advertised during the month of March 2020. Bids were received and opened on April 21, 2020. Funding in the amount of three million four hundred-thirty-two thousand three hundred nineteen dollars (\$3,432,319.00) was provided by the State and the County in FY20 and FY21.

Discussion:

Seven (7) contractors submitted bids for the project. Simpson of Maryland, Inc. submitted the responsive and responsible low base bid in the amount of one million two hundred seventy-eight thousand seven hundred seventy-two dollars (\$1,278,772.00) and recommended Alternate #2 in the amount of forty-one thousand five hundred dollars (\$41,500.00). A bid tabulation and description of the alternates are attached. Simpson of Maryland, Inc. has done work with Maryland Public Schools. Minority Business Enterprise (MBE) participation on this project will be 25%.

Superintendent's Recommendation:

The Superintendent of Schools recommends that the Board of Education approve a contract for the above described construction services for the Hickory Elementary School Comprehensive Roofing Project in the amount of \$1,320,272.00, to Simpson of Maryland, Inc. The amount of award is the sum of the base bid and Alternate #2.
