### DECISION ON AWARD OF CONTRACT HALL'S CROSS ROADS ELEMENTARY SCHOOL CHILLER REPLACEMENT

March 27, 2023

### **Background Information:**

Bid documents for the Hall's Cross Roads Elementary School Chiller Replacement Project were issued and advertised during the month of February 2023. Bids were received and opened on February 28, 2023. With the FY 2023 CIP submission, six hundred forty-one thousand one hundred dollars (\$641,100.00) was requested from the State Healthy Schools Facility Fund and the local match in the amount of four hundred fifty thousand dollars (\$450,000.00) was requested in the FY 2023 local CIP. The total approved State and the County maximum allocation for the project is one million ninety-one thousand one hundred dollars (\$1,091,100.00).

### **Discussion**:

Eleven (11) contractors submitted bids for the project. BMC Services, LLC submitted the responsive and responsible low bid in the amount of four hundred ninety-nine thousand six hundred twenty-six dollars (\$499,626.00). A bid tabulation is attached. BMC Services, LLC has done work with Baltimore City and Baltimore Public Schools. Minority Business Enterprise participation on this project will be 10%.

### Superintendent's Recommendation:

The Superintendent of Schools recommends that the Board of Education approve a contract for the above-described construction services for the Hall's Cross Roads Elementary School Chiller Replacement Project, in the amount of four hundred ninety-nine thousand six hundred twenty-six dollars (\$499,626.00), to BMC Services, LLC.
