

# BOARD OF EDUCATION OF HARFORD COUNTY

## Proposed 2024-2025 HCPS Calendar

September 18, 2023

### **Background Information:**

Each year, the Board of Education of Harford County appoints a Calendar Committee to make recommendations for the “out year” Harford County Public Schools calendar. The 35-person committee – composed of representatives from the community and the school system – is charged with recommending a proposed calendar for the upcoming school year. The committee meets and attempts to reach consensus on the proposed “out year” calendar during the month of September. The Board holds the proposal over for at least 60 days to allow for public comment (the proposed calendar is placed on the HCPS website). The public comment is reviewed by the Board appointed calendar committee and Board members. The committee provides a proposal with public comment taken into consideration to the Superintendent who reviews it and makes a recommendation to the Board to adopt the calendar as proposed by the committee or with suggested changes. The Board then votes to adopt a calendar for the “out year” at a subsequent meeting.

### **Discussion:**

This year, the membership of the 2024-25 Calendar Committee (roster attached) was approved by the Board of Education at its August meeting. The committee met on September 7, 2023. Two versions of the calendar are being presented for public comment and a subsequent Board vote. Both calendars feature: The 180-day student/190-day teacher calendar (grid attached) contains the following features:

- 180 student days
- 190 teacher days
- Thanksgiving break
- Winter break
- Spring break
- Professional development and early dismissal days: schools are closed to students to allow staff learning.
- Holiday closures per negotiated agreements: schools and offices are closed to students and staff.
- Inclement weather days built into the calendars.

### **Superintendent’s Recommendation:**

The Superintendent recommends the Board accept the proposed 2024-2025 school calendars as presented by the Calendar Committee for 60 days of public comment.
