I. Purpose

The purpose of this policy is to establish that all students, while being transported by Harford County Public Schools (HCPS), are subject to the HCPS disciplinary policies.

II. Statement of Policy

- A. All students are subject to all HCPS disciplinary policies including all school disciplinary policies while embarking, exiting, riding on HCPS school vehicles or other vehicle transporting students while under the control and supervision of HCPS.
- B. The principal of the school of the student in question shall have authority to implement such disciplinary policies while the students are transported as described above in paragraph A.
- C. The school bus driver shall have full authority and control regarding the school vehicle he or she is operating unless otherwise provided by the school principal or the Director of Transportation.
