

- I. Purpose  
The purpose of this policy is to establish criteria and a framework for curriculum implementation in Harford County Public Schools.
- II. Definitions-None
- III. Policy Statement
  - A. The Harford County Public Schools Division of Curriculum, Instruction, and Assessment shall be responsible for the curriculum management plan and the selection/development of all written, taught, and assessed curricula.
  - B. Alterations impacting the scope and sequence of a current curriculum must be reviewed and approved by the Superintendent of Schools or his/her designee before being implemented.
  - C. All curricula described in paragraphs A and B above must be reviewed by the Superintendent of Schools or his/her designee and recommended to the Board of Education for adoption.
  - D. Approved curricula and system-wide directives regarding the instructional program, student activities, and/or school-related experiences which are planned for students are to be implemented with fidelity, as ensured by administrative and supervisory personnel.
