



19th ANNUAL SCHOLARSHIP AWARD PROGRAM

2025 Application

Point Breeze Credit Union will award **twenty (20) \$2,000 scholarships** to eligible members currently in their senior year of high school and planning to attend a full-time accredited two- or four-year college or an accredited technical school of their choice in 2025.

All applications will be judged by our Scholarship Committee. Personal information will be redacted prior to review by the Scholarship Committee. Awards will be made during the month of June 2025. Checks will be made payable jointly to the recipient and the school of their choice. All decisions are final.

Eligibility Requirements/Application Checklist:

Please complete the application in its entirety. **Incomplete applications will not be considered.**

- Applicant must be graduating from high school in 2025.
- Applicant **must be a current owner, joint owner or named on a custodial account** in good standing with Point Breeze Credit Union. The account must remain in good standing to be eligible for a scholarship award. Family members of employees, board members or committee members are eligible to participate in the scholarship program.
- A Letter of Acceptance from the school of your choice is required at the time the application is submitted or before the scholarship is awarded to the student. Please indicate on the application if you are waiting to receive your Letter of Acceptance.
- Two references, **one personal and one academic**, must be submitted with the application. Personal reference must be someone other than a family member.
- Typed application, essay and questionnaire responses must be complete and will be judged on ideas, originality and writing conventions. *Please do not submit handwritten applications.*
- Application must be signed and dated. **All applicants under the age of 18 must have a parent/guardian signature.**

Completed applications must be submitted to scholarship@pointbreezecu.com or hand-delivered to a Point Breeze Credit Union office by April 30, 2025. Applicants will be notified in writing of the committee's decision in June 2025.
