

Harford County Environmental Scholarship Program

Beginning with the 1991 graduating class, a scholarship program has been offered at each high school in Harford County for seniors intending to prepare for a career dealing with the environment. You are invited to apply for this scholarship if you intend to pursue a career that will promote environmental quality. Your school will select a winner for a grant funded through the generosity of a local corporate sponsor.

Your application will be judged first by an in-school faculty committee, appointed by your principal, to include at least one teacher of science, at least one school counselor and at least one building administrator. That committee will evaluate your application based on the following criteria:

- The intent to pursue a career that would promote environmental quality
- Your demonstrated commitment to volunteer efforts for the improvement of the environment and the quality of life in your community
- Your past performance in academic achievement that would indicate success in obtaining a post-high school education

Applications will be available January27th through your school's counseling office /Environmental Scholarship building contact and are **due** (**completely filled in**) **back in your school's counseling office by March 7th**. Each school's decision along with the application of the school's winner is **due to Kathy Houston at Harford Glen by March 31st**. All award announcements will be mailed on April 28th. Any award money which you may be granted will be sent directly to the school which you will be attending and must be claimed by December 31, 2025.
