3. **QUESTION**: I received the Bid announcement. Is the Equipment in each group specific to that brand? For example group 1 is Kubota. We are Bobcat but offer the same types of equipment. Additionally, are there certain specification criteria that each piece should be within. Example: Kubota- Track Loaders. What weight? Enclosed or open cab? Bucket capacities? Type of controls? Etc. I ask these questions in regard to Group 1, 2, 9, 10, 14, 21, 24, 25, 27, and 28. As I mentioned we are Bobcat Company and we offer the same type of equipment as each of these groups and I would appreciate an opportunity to bid for like items.

<u>ANSWER</u>: For Sections A and E, the items are brand specific. Bidders shall be authorized or certified by the manufacturer to sell OEM parts for these sections to submit a price. For Section B and C, vendors can bid on any items in this category if they wish. This bid will only cover the brands listed with no exceptions.

4. **QUESTION**: Line 50 Track Loaders: Would this be rubber track compact track loaders? Large Construction Steel Track Loaders as well?

ANSWER: Rubber track compact skid loaders only.

5. QUESTION: Line 50 Skid Loader: Would this be rubber tire skid steer loaders?

ANSWER: Line 51 Skid Loader, rubber tire skid loader.

6. **QUESTION**: Line 52 Wheel Loaders: Would this be compact wheel loaders? Large Construction wheel loaders as well?

ANSWER: Compact wheel loaders only.

7. **QUESTION**: Line 54 Excavators: Would this be compact excavators? Large Construction excavators as well?

ANSWER: Compact excavators only.
