IV. <u>EMPLOYMENT OF SEX OFFENDERS AND OTHER CRIMINAL OFFENDERS</u>

- A. Section 11-722 of the Criminal Procedure Article of the Maryland Code prohibits any person with a contract with a local Maryland school system from knowingly employing an individual to work at the school if the individual is registered as a sex offender pursuant to Section 11-704 of the Criminal Procedure Article.
- B. The Contractor shall acknowledge the following requirements of Section 11-722 of the Criminal Procedure Article, and Section 6-113 of the Education Article, Annotated Code of Maryland.
- C. Direct unsupervised and uncontrolled access with students is prohibited. If you, as the Contractor/Site Supervisor, witness or suspect your employee(s) entering into a student area, action must be taken immediately to rectify the situation.
- D. The apparent low bidder shall complete and submit the Employment of Sex Offenders and Other Criminal Offenders Affidavit, (Section 006400), which is specified in the bid documents within ten (10) working days after notification that the firm is the apparent low bidder.

VII. QUESTIONS, COMMENTS, CONCERNS

- Q: Are condensing boilers acceptable for boiler replacement?
- A: No. Only non-condensing gas-fired boilers will be considered for the alternate. Base bid manufacturer is Weil-McLain. Acceptable alternate manufacturers are Riello, Cleaver-Brooks, and Lochinvar as listed in the specifications.
- Q: What is the size of the existing buried fuel-oil tank to be removed?
- A: The tank is assumed to hold approximately 10,000 gallons of fuel and is about 18-20' in length. Top of tank is approximately 20 inches below grade. These dimensions should be confirmed via field investigation prior to excavation.
- Q: Are specifications available for the buried propane tanks?
- A: No dedicated specification will be provided for the propane tanks. Tanks shall be capable of storing specified volume and shall include cathodic protection. Recommended manufacterer is Ray Murray Inc., but substitutions are acceptable. Tanks shall be installed according to details and manufacturer recommendedations.
