

The purpose of this letter is to share with you a scholarship available to Harford County graduating seniors exhibiting exemplary service to their school and their community. We hope you and your school will work together with us to offer accolades to young men and women who unselfishly dedicate time to their school and/or their surrounding community.

The Charlie Riley Community Service Scholarship Foundation was formed over fifteen years ago and this fall we will be recognizing a senior from each of Harford County's twelve high school graduating classes. Last November we recognized seniors from all twelve high schools in the county and Sarah Carven from C Milton Wright High School was recognized as the grand prize winner in the high school category. This year each nominee will receive a scholarship worth at least \$2000 and the grand prize winner will receive an additional scholarship worth \$1000 more. Our awards ceremony will be held on Wednesday, November 12, 2025.

The foundation is inviting each high school to form a nomination committee designed to select one graduating senior who best exemplifies service to school and/or community. Once the selection is made the applicant must complete the attached application packet. The packet must be RECEIVED by the selection committee by 7:00 pm on the evening of September 26, 2025. Each school's nominee will be invited to the awards ceremony where they will be receiving recognition for their service. Again, each nominee will receive a scholarship worth at least \$2000 and the grand prize winner will receive an additional scholarship worth \$1000 more to an institution of higher learning.
