The omission of specific duties does not exclude them from the position if the work is a similar, related, or logical assignment to the position.</li> <li>Serves as the school representative/liaison during after-school Covid screening testing program between the testing vendor, school personnel and students.</li> <li>Monitors or audits attendance to ensure student testing compliance.</li> <li>Communicates to the appropriate after-school program personnel (athletics or fine arts) if students are not in compliance with the testing program.</li> <li>Work Schedule</li> <li>One day per week (TBD)</li> <li>Up to 3-4 hours on assigned testing day (all hours are after the duty day and typically starting immediately after the instructional day concludes) <ul> <li>specific times to be determined by the school administration</li> <li>i.e., 2:30 – 6:30</li> </ul> </li> <li>Starting week of November 15, 2021 <ul> <li>Paid training will be provided prior to official start date.</li> </ul> </li> </ul>
SALARY	<ul> <li>HCEA - paid at \$25 per hour negotiated rate</li> <li>HCEA-ESP, AFSCME – paid hourly per diem rate of pay. Any hours worked beyond 40 hours per week (in combination with regular HCPS assignment) will be compensated at time and one-half.</li> </ul>
